Outdoor lessons and experiential learning has become a quick and proven method of learning.

We at, **NAF Chapter Kullu**, aim to help participants understand the natural environment and to impart training in skills that will heighten their enjoyment of the great outdoors. Learning adventure skills and participating in outdoor activities to develop not only one's physical ability but sharpens mental ability as well.

NAF Chapter Kullu, an organization dedicated to the spirit of adventure. The Organization is **registered with Sub-registrar Societies, Kullu, Government of Himachal Pradesh** and is comprised of dedicated people who contribute their expertise and experience towards crafting special, customized tours for the clients. OBJECTIVES

- To impart technical skills in Land based adventure pursuits.
- To develop personal leadership qualities.
- To familiarize participants with the great outdoors.
- To create an awareness of the natural environment.
- To introduce participants to the people and cultures of the Himalayan region.
- To impart responsible outdoor adventure and survival skills.
- To channelize the energy of the youth of the nation towards Adventure sports from the ever luring "drugs"

LOCATION

The office of the **NAF Chapter Kullu** is located at Pirdi, a small village near Kullu, best known as rafting starting point. Pirdi is accessible both by air and road from Chandigarh, Pathankot and New Delhi.

AREA OF OPERATION

Though **NAF Chapter Kullu** is based at Pirdi and the official area of operation comprises the whole district of Kullu excluding Manali Tehsil boundary, yet few of our operations extend from beautiful hill stations of Himachal Pradesh to high lands of Ladakh, from barren Zansker to mighty Lahoul & Spiti valleys.

ACTIVITIES

Our programme profile outlines the various activities organized and operated by **NAF Chapter Kullu**. These land based adventure activities are divided into summer adventure camps, Technical camps and snow skiing camps. Further details on each of the camps are available on our web site.

CAMPS CALENDER AND FEES

Our Camps Calendar & Fees enclosure details our annual schedule and fees for all activities conducted by us. This leaflet for updated calendar & fees will be uploaded on the web site every year in November.

OTHER ACTIVITIES

Apart from adventure training Camps **NAF Chapter Kullu** organizes treks, mountaineering expeditions, mountain biking Tours, motorbike expedition, monastic tours, angling etc.

We also organize group tours for school, college and other institutional groups. Such group should get in touch with us their requirements and we would customize an itinerary for them. Once the itinerary is finalized we'll give the cost for the same. If this cost is mutually accepted and finalized, the booking procedure will start.

LANGUAGE OF INSTRUCTION

The medium of the instruction is mainly English, though Hindi is also used to clear the point to the participants. Large groups are divided into smaller tutorials so as to ensure a degree of individual attention to each participant.

NUMBER LIMIT OF PARTICIPANTS

For reasons of safety, quality of supervision, environmental impact and financial viability, we set limit to the number of participants on each camp. Camps shall normally not be operated should participant levels fall below the minimum indicated for that programme. In such cases, a small surcharge will be advised and should those booked/confirmed agree to pay the extra cost, the camp will be operated. Participant's levels will be raised above indicated numbers only when special arrangements are requested and block reservations made.

PARTICIPANTS ELIGIBILITY

NAF Chapter Kullu's Camps are open to all educational institutions, schools and colleges, government institutions, non-government institutions, corporate houses and their HRD departments, youth clubs and societies, as well as to individuals – students and senior citizens. Anyone who is medically and physically fit, and meet the age criterion can participate. Though there is no upper age limit, we do apply a lower age limit which is indicated in our Camps calendar & fees enclosure. For persons below 12 years, the written consent of their parent/guardian is mandatory.

PHYSICAL/MEDICAL FITNESS & MEDICAL COVER

All outdoor activities demand a certain level of physical and medical fitness, these being essential prerequisites for all **NAF Chapter Kullu's** programmes. Each participant is required to be examined by a registered practitioner and our medical certificate duly filled out by him/her and returned to us along with the application for registration and fees.

NAF Chapter Kullu retains the right to reject any candidate whom they feel is not up to the required physical and medical standard.

NAF Chapter Kullu provides group medical kits for each camp. Participants are required to bring along their own personal medical kits, suggested contents of which will be provided with the final documentation.

We retain the services of a local medical practitioner in Kullu for purposes of attending to all medical emergencies that participants may suffer from during our courses. A clinic in Kullu can also be called upon in case hospitalization is required. However, additional costs resulting from medical consultation and hospitalization are not covered in our course fees and will be on participant's personal account.

ACCOMMODATION & MEALS

Accommodation is provided in tents or village huts, dormitory style or on a shared basis, though sometimes twin sharing facilities with community-use toilets are provided. Meals, mainly vegetarian, are balanced, wholesome and nutritious. These are prepared by our camp staff using locally available fresh ingredients.

EQUIPMENT

All technical and camping equipment is provided by **NAF Chapter Kullu**. Items of personal nature such as clothing must be brought by participants. A list of requirements will be sent along with the final documentation.

LEAVE & HOLIDAYS

No leave is permitted during training nor are any holidays observed through the tenure of our Camps.

HOW TO REGISTER

Having selected the activity of one's choice and arrived at the preferred dates, the **NAF Chapter Kullu** registration form is to be filled out and returned to us along with the camp fees; additional details being required from foreign nationals and students.

CLOSING DATES FOR REGISTRATION

For administrative reasons we close registration for our courses 15 days prior to the commencement date indicated in our Camps Calendar. Request for registration must be received at our office well before this date. Late requests are not entertained.

WAITLISTS

Since vacancies on our camps fill up early, we recommend that participants apply as soon as possible in order to secure confirmed space. When camps fill up, we waitlist participants or offer them alternative dates or vacancies on other camps. Such waitlisted individuals will be advised of their registration becoming confirmed as when cancellations are received.

TERMS & CONDITIONS OF REGISTRATION

The Terms & Conditions of registration are detailed in a separate paragraph and contains our policy on advance deposits, final payment, cancellation and refund; along with a statement on **NAF Chapter Kullu's** responsibility.

TRAVEL ARRANGEMENTS

All travel arrangements to **NAF Chapter Kullu's** Camp locations and back are under the own arrangements of participants. We will however be able to advice on the best road, train and air connections. Arriving participants will receive intimation about our meeting point and reception arrangements at our office along with the final documentation.

COSTS COVERED BY THE FEES

The camp fees cover boarding and lodging, technical and community – use equipment, including climbing hardware and ski gear, supervision and inspection by qualified trainers, the provisioning of training aids and use of porters and pack animals.

COSTS NOT COVERED BY THE FEES

The fees do not include pre/post camp arrival/departure, facilitation/travel cost to and from Camps joining and dispersal locations, etc., and cost of any form of insurance, rescue, evacuation, hospitalization, etc., and costs incurred due to delays in arrival/departure of any means of transportation resulting from landslides, floods, or other natural or manmade causes over which **NAF Chapter Kullu** has no control.

CERTIFICATES

Certificates are awarded to participants who successfully complete any **NAF Chapter Kullu's** Camp or specially organized outdoor adventure activity.

INSURANCE COVERING CANCELLATION OF CAMP/TRAVEL ARRANGEMENTS & PERSONAL MEDICAL/ ACCIDENT INSURANCE

As mentioned earlier, camps operate only when minimum participant levels are reached. Should **NAF Chapter Kullu** be constrained to cancel a camp for this reason, participants already booked will be advised of this and all payments made by them will be refunded. Any extra pre-camp costs incurred by participants in preparation for a camp that **NAF Chapter Kullu** subsequently cancels, i.e., for purchasing items of

personal clothing, for joining fitness classes, for getting medical tests done, for travel arrangements that have to be ultimately cancelled, etc., will not be a **NAF Chapter Kullu** responsibility but that of the individual participant. An insurance to cover such contingencies, if available, is highly recommended.

All adventure camps are closely supervised by our trained staffs that possess a thorough knowledge of basic first aid skills. However, we do not have physicians on call at our camps and any injuries or ailments that require professional attention and organized with outside assistance and at extra cost. In view of this, we strongly recommend that personal medical/ accident insurance covers are taken by all participants before attending any **NAF Chapter Kullu** camp.

NAF CHAPTER KULLU'S RESPONSIBILITY AND INDEMNIFICATION

The limits of **NAF Chapter Kullu** responsibility are clearly indicated in our Terms & Conditions of registration. By virtue of applying and paying for any **NAF Chapter Kullu's** camp or other adventure activity, the participant agrees to accept the limits of our responsibility and indemnifies us from all vicarious liabilities.

Each participant is required to release **NAF Chapter Kullu** of such responsibilities, and he / she assume such risks as are inherent in type of adventure activities conducted by us and for which the registration is made. For this purpose, our indemnity bond is to be filled out by the participant, signed and returned to us at the time of registration. Failure to do so shall invite cancellation of the registration and forfeiture of any payments already made.

FINAL DOCUMENTATION

Participants confirmed on our camps or other outdoor activity/programmes will receive the following documentation well before the reporting date:

- Confirmation voucher
- Receipt of payments
- Copy of detailed camp programme
- Do's & Don'ts, while at Camp
- Joining instructions
- Checklist of personal equipments and clothing
- Checklist of personal medical kit

PROGRAMME PROFILE

Developing individual leadership qualities through the process of learning outdoor skills and participating in adventure activities is a proven theory. The ability to survive in remote areas and to make quick decisions in adverse conditions together helps sharpen the thinking process. Each camp includes strategy, planning, competitive events, performances, analysis, and other group activities that are

aimed at team building and developing the personality of the individual in a well rounded manner.

In order to enjoy nature in a sustainable manner, it is of prime importance to respect and protect it in all its manifestations. Environmental awareness and an active concern for the conservation of wilderness areas are essential cornerstones of learning on all **NAF Chapter Kullu's** training camps.

The following is a brief profile of our "Land" oriented training camps currently on offer at **NAF Chapter Kullu**

ADVENTURE CAMPS

1. 6 DAYS STUDENT'S ADVENTURE CAMP

This is a basic camp designed to familiarize the novice with the fundamentals of outdoor living. The programme, while including an introduction to the Himalaya, Route selection, camping, outdoor cooking and elementary rock climbing techniques, mainly involves short treks into the mountains from static or roaming camps.

2. 7 DAYS WILDERNESS TRAINING CAMP

This is an introductory camp designed to impart outdoor housekeeping and survival skills. During the camp basic mountaineering techniques are taught. These include map reading and compass work, elementary first aid, trekking and river fording, and practice in route selection. Participants are also introduced to the fundamental values involved in the conservation of mountain environments.

TECHNICAL CAMPS

3. 5 DAY ROCK CLIMBING CAMP

Rock climbing camps are aimed at both the novice as well as the experienced participant. For the novice, a basic camp is run on camping and equipment planning and management. Along with the opportunity of climbing short and long rock pitches, practice in the art of rappelling is also imparted. For the more experienced, this is an opportunity to sharpen technique under the supervisor, of our skilled trainers and to further knowledge on various aspects of mountain safety.

4. 15 DAY MOUNTAINEERING CAMP

This training camp develops one's ability to climb peaks up to an altitude of 5500 meters. Practice in movement on mixed terrain and skills in managing equipment are imparted. Participants are also trained in the art of developing an understanding for the various moods that the mountains never fail to exhibit.

5. 12 DAY SNOW AND ICE CLIMBING CAMP

This training camp is aimed at people who already have a certain level of mountain experience. Conducted at the snout of a glacier, the subjects covered

include acclimatization, rock climbing, familiarization with the technical equipment and practice in its use, moving on snow and ice, avalanche survival, and practice in the negotiation of steep ice slopes. Besides creating an awareness of high mountain environments, participants are also provided with the opportunity of developing proficiency in survival skills under extreme weather conditions at high altitudes.

SNOW SKIING CAMPS

6. 6 DAY SKIING CAMP

This camp is conducted at SolangValley which is a famous skiing spot, and at Gulaba, and RohtangPass areas. Basic and advanced skiing skills, camping in snow bound conditions and avalanche rescue techniques are sum of the subjects covered during this camp.

TERMS & CONDITIONS OF REGISTRATION

NAF Chapter Kullu, including its executives, management and employees, agents and associates, accepts applications for registration for various adventure training camps and other outdoor activity programmes on the following terms and conditions.

ADVANCE DEPOSITE

An advance deposit of Rs. 500 (for Indian nationals) or USD 150 for overseas nationals and NRI's, per person is required at the time of registration in order to secure a place for the camp or activity applied for. This is a non refundable, non transferable deposit and will only be refunded to the applicant if a place cannot be offered or **NAF Chapter Kullu** is constrained to cancel a scheduled camp or activity applied for.

FINAL PAYMENT

The balance of camp fee is due in full, six weeks before the commencement of the programme. **NAF Chapter Kullu** reserves the right to cancel any reservation for any camp or activity should this balance payment arrive later than the stipulated period. In such cases, any prior payments made will be forfeited by the applicant

Applications made less than six weeks prior to the commencement of any camp will be considered subject to full payment(advance deposit and final payment) being received before registration close, i.e. up to 15 days before start date.

MODE OF PAYMENT

Both the advance deposit and final payment are required through NEFT, Demand Drafts, favouring **NAF Chapter Kullu**, drawn on SBI, Mohal, Kullu branch.

CANCELLATION AND REFUNDS

All cancellations are required in writing and should reach NAF Chapter Kullu at least 30 days prior to the commencement of the programme. Cancellations made less than 30 days in advance of programme commencement will invite forfeiture of all amounts already paid. Cancellations intimated more than 30 days prior to activity commencement will invite a cancellation charge amounting to 50% of full camp or Activity fees.

RESPONSIBILITY

The NAF Chapter Kullu, its owners, executives, management and employees, agents and associates, while exercising every possible precaution in the planning organization, equipping and conduct of their camps and adventure activities, shall not be held responsible for any personal injuries, including fatalities, other accidents or loss of life or limb or property, travel delays or cancellations, including but not limited to any defects in vehicles used, acts of God or default of any agency or person engaged in conveying passengers, wilful or negligent acts of omission on the part of agencies or person(s) engaged in conducting NAF Chapter Kullu's activities, any natural calamities, labour strikes, theft or pilferage, force major , government restrictions or regulation or civil disturbances. The participant understands that certain risks are involved and danger may exist during **NAF Chapter Kullu Camp/activities** and agrees to bear full responsibility for any risk or danger and that no liability will be borne by **NAF Chapter Kullu** and / or its owners, executives, management and employees, agents and associates should such an act occur or eventuality be fall.

NAF Chapter Kullu reserves the right to re schedule, modify, alter, substitute, cancel or withdraw any camp or activity programme, arrangement or itinerary and shall not be responsible for extra cost or any difficulties resulting from improper documentation or negligence in arrangements involving passports, visas, entry permits, travel documents, etc.. The participant agrees to accept and pay any surcharges levied, should camp size or participants sign ups not come up to estimated levels that have been costed for and advertised.

NAF Chapter Kullu reserves the right to decline, accept or retain any person as members of a group or party or participants at any time regardless of whether a camp or activity programme has commenced or not.

The participants agrees to accept the direction of **NAF Chapter Kullu** authorities and shall abide strictly with laid down discipline, procedures and behavioural codes enforced by our executives, staff, employees, associates and agents. No refunds for any arrangements, whether costed for and realized, whether provided or not, will be entertained under any circumstances where breach of **NAF Chapter Kullu** programme routine, discipline or codes of conduct are involved.

Policies

All bookings for the camps/trips/tours/treks with **NAF Chapter, Kullu**, hereinafter referred to as the "NAF" are subject to the following conditions:

1. Every participant is required to read our Terms & Conditions thoroughly and fill in the booking form in capitals and in own handwriting. An "Indemnity Bond" also needs to be signed by the participant. No booking will be confirmed without it. A soft copy of the booking form and Indemnity are to be E-mailed to us and hardcopy has to be handed over to us at the base camp.
2. All the bookings will be confirmed with the full and final amount of the excursion.
3. NAF reserves the right to alter details of the services, facilities, Camp/trip/tour/trek and vehicle described in the itinerary at any time, when deemed necessary, reasonable and advisable.
4. During the excursion, the decision of the Leader will be final and binding.
5. Maximum efforts are made to ensure the safety of the participant. But please understand there are certain hazards involved in your adventurous holidays which cannot be foreseen and you must accept at your own risk. The "NAF Chapter" will not be liable for any major illness, injury, death sustained during the trip, nor will it be liable for any uninsured losses of your property.
6. In case any participant falls sick during the excursion, the medical, travel, porter and any other expenses has to be borne by the concerned individual. However, primary medical facilities will be made available wherever possible.
7. Any damage, other than that attributable to fair wear and tear, to the equipments by the participants will be billed to him/her. Our decision on all such matters will be final and binding.
8. All cancellations must be in writing, signed by the participant and will be effective from the date of receipt by NAF. Only registered E-Mail shall be used for all the correspondence.
9. Refund and cancellation: There will be no full refund.
 - If you cancel 30 days before the trip begins, NAF will retain 25% of the trip cost.
 - If you cancel 15 days before the trip begins, NAF will retain 50% of the trip

cost.

- If you cancel less than 15 days before the trip begins, or, are not present when the trip begins, there will be no refund.

- No refund or adjustment will be made to any participant who voluntarily leaves a trip en-route.

10. Consumption of Narcotic drugs and alcohol during the excursion will terminate your trip instantly.

11. NAF will have the right to use guest details, pictures, blogs and any other type of intellectual material related to the excursion booked with us, for its promotional purpose but cannot sell it to third party.

12. In the event of any dispute, all matters will be subject to the sole jurisdiction of the courts of Kullu, Himachal Pradesh and the prevailing law shall prevail.
